Specifically failed to comply with the following:

- s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:
- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).

Findings/Faits saillants:

1. The licensee has failed to ensure that a person who had reasonable grounds to suspect abuse of a resident reported the alleged abuse immediately to the Director.

On a specific date, the home submitted a Critical Incident System (CIS) report of a resident reporting to a staff alleged abuse from a staff member towards them, an incident that occurred the day before the CIS was submitted. In an interview with the Administrator, they said they were unaware the incident occurred the day before. They confirmed it was alleged abuse and should have been reported immediately to the Director.

The staff's failure to immediately report alleged abuse of a resident posed a risk of harm to the resident and residents in the home.

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that a person who had reasonable grounds to suspect abuse of resident #001 to report the alleged abuse immediately to the Director, to be implemented voluntarily.
