The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): January 8, 2015

An inspection (2014-189120-0022) was previously conducted on April 15, 2014 at which time an order was issued for non-compliance related to bed safety. A follow-up inspection (2014-189120-0050) was conducted on July 29, 2014, however the conditions laid out in the order were not complied with and another order was issued. For this visit, the conditions laid out in the order have been met.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care and Maintenance person regarding bed safety. The licensee's bed entrapment audit report was reviewed, a tour of random resident rooms was completed and 3 random resident care records were reviewed.
