Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 88. Pest control  
Specifically failed to comply with the following:**

**s. 88. (1) As part of organized programs of housekeeping and maintenance services under clauses 15 (1) (a) and (c) of the Act, every licensee of a long-term care home shall ensure that an organized preventive pest control program using the services of a licensed pest controller is in place at the home, including records indicating the dates of visits and actions taken. O. Reg. 79/10, s. 88 (1).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that as part of organized programs of housekeeping and maintenance services under the clauses 15 (1) (a) and (c) of the Act, records of a licensed pest controller, including the dates of visits and actions taken, were in place at the home.

A review of complaint intake #011188-20, indicated that an identified pest had been observed in a specified location, in the home.

During an interview with the Administrator on an identified date, the Ministry of Long-Term Care (MOLTC) inspector requested the reports for visits provided by a licensed pest controller, for a specified period of time.

The Administrator indicated the home used the licensed service of a specified company. The Administrator was able to provide invoices of the services provided by this company to the home; however, indicated the home had not received reports following each visit to the home. The Administrator obtained and provided the requested reports the following day and confirmed their request to the licensed company to provide reports ongoing, following each visit at the home.
