1. The licensee has failed to ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber.

Resident #001 was admitted to the home with an identified diagnosis which required medication management.

On an identified date, the resident had a follow up assessment with an external consultant and returned to the home with an order to change the prescribed medication. The order directed staff to administer specific doses of the identified medication based on the reading of specified tests. The order further directed staff to monitor specific factors where the medication needs to be withheld. The order was transcribed and processed by staff #001 and #002 with the omission of directions regarding the identified factors to withhold the medication.

Record review revealed and interviews held with staff #001, #002 and the Director of Care (DOC) confirmed that the medication was not administered to resident #001 as directed in the order.

On a specified date, the licensee submitted a critical incident report to the Director reporting that on an identified date, resident #001 was found unresponsive in his/her room. Life saving efforts were initiated but found to be unsuccessful. The resident passed away in the home. The home conducted an internal investigation and indicated that the resident did not pass away as a result of the medication error.

Further interviews held with staff #'s 001, 002 and the DOC confirmed that the identified medication was not administered to resident #001 as in accordance with the directions for use specified by the prescriber. [s. 131. (2)]

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)  
the licensee is hereby requested to prepare a written plan of correction for  
achieving compliance to ensure that drugs are administered to residents in  
accordance with the directions for use specified by the prescriber, to be  
implemented voluntarily.***
