WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 65. Recreational and social activities program Specifically failed to comply with the following subsections:

- s. 65. (2) Every licensee of a long-term care home shall ensure that the program includes,
- (a) the provision of supplies and appropriate equipment for the program;
- (b) the development, implementation and communication to all residents and families of a schedule of recreation and social activities that are offered during days, evenings and weekends;
- (c) recreation and social activities that include a range of indoor and outdoor recreation, leisure and outings that are of a frequency and type to benefit all residents of the home and reflect their interests;
- (d) opportunities for resident and family input into the development and scheduling of recreation and social activities;
- (e) the provision of information to residents about community activities that may be of interest to them; and (f) assistance and support to permit residents to participate in activities that may be of interest to them if they are not able to do so independently. O. Reg. 79/10, s. 65 (2).

Findings/Faits saillants :

1. According to the Manager of Programs programs for the months of September, October, and November, 2012, The Recreation Therapist's days off were not covered. The licensee scheduled and posted the following programs for the residents on the York/Humber unit which were not provided to the residents:

September 13 - 2:00 pm program "Chatabouts".

September 19 - 10:30 am program "Puzzles & Things".

September 27 - 1:30 pm "Chatabouts".

October 3 - 10:00 am "Puzzles & Things"

October 11 - 2:00 pm the Manager was unsure if this program was delivered or not.

October 29 - 2:00 pm "Snoezelen"

November 1/12 - Montessori Program at 10:00 am and Balloon Badminton at 2:00 pm.

November 8/12 - Snoezelen Program at 10:00

November 12/12 - Snoezelen Program at 2:00

On November 14, 2012 the morning activity program of Puzzles & Things scheduled to run at 10:00 am was not implemented. According to a staff member, the Recreation Therapist was pulled from the Humber/York unit to provide activity programs on another unit due to staff absenteeism on that unit.

A York/Humber staff member confirmed that none of the residents from York/Humber unit attended the Church Service program on November 14, 2012 at 10:00 [65(2)(c)].
