Findings/Faits sayants :

1. Staff did not consistently provide the plan of care related to a resident's safety requirements.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure all staff provide the care requirements as per the plan of care , to be implemented voluntarily.
