WN#1: The Licensee has failed to comply with O. Reg. 79/10 s17(1)(a):

Every licensee of a long-term care home shall ensure that the home is equipped with a resident-staff communication and response system that,

(a) can be easily seen, accessed and used by residents, staff and visitors at all times

Findings:

1. Two identified residents were observed sleeping on their beds without access to the call bell system.

WN#2: The Licensee has failed to comply with LTCHA, 2007, S.O. 2007 s3(1)8

Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

8. Every resident has the right to be afforded privacy in treatment and in caring for his or her personal needs.

Findings:

1. One resident was not afforded privacy during a bed bath. The privacy curtain was not used during the bathing procedure.

Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

Findings:

1. Review of the registered staff work schedule for July1-17/10 confirmed a Registered Nurse was not scheduled to work for 33 of the required shifts. The evening Registered Nurse position was vacant at the time of the inspection.

Further Inspector Actions:

VPC - Pursuant LTCHA, 2007, S.O. 2007, c.8, s. 152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to be implemented voluntarily.

WN#4: The Licensee has failed to comply with O. Reg. 79/10 s26(3)15

A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident:

15. Skin condition, including altered skin integrity and foot conditions.

Findings:

1. The plan of care for one resident does not include nutritional interventions related to promotion of wound healing.

WN#5: The Licensee has failed to comply with O. Reg. 79/10 s50(2)(b)(iv)

Every licensee of a long-term care home shall ensure that,

(iv) is reassessed at least weekly by a member of the registered nursing staff, if clinically indicated;
