**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19.
Duty to protect**

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee has failed to protect residents from abuse by anyone.

On a specified date in 2016, resident #002 experienced abuse by resident #001.

Resident #001 had demonstrated a change in behaviours for several days prior to the incident involving resident #002.

Resident #002 was distressed by the actions of resident #001.

The licensee failed to protect resident #002 from abuse by resident #001. [s. 19. (1)]

Additional Required Actions:

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance protecting residents from abuse by anyone and ensuring
that residents are not neglected by the licensee or staff, to be implemented
voluntarily.**
