WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 148. Requirements on licensee before discharging a resident

Specifically failed to comply with the following:

s. 148. (2) Before discharging a resident under subsection 145 (1), the licensee shall,

(a) ensure that alternatives to discharge have been considered and, where appropriate, tried; O. Reg. 79/10, s. 148 (2).

(b) in collaboration with the appropriate placement co-ordinator and other health service organizations, make alternative arrangements for the accommodation, care and secure environment required by the resident; O. Reg. 79/10, s. 148 (2).

(c) ensure the resident and the resident's substitute decision-maker, if any, and any person either of them may direct is kept informed and given an opportunity to participate in the discharge planning and that his or her wishes are taken into consideration; and O. Reg. 79/10, s. 148 (2).

(d) provide a written notice to the resident, the resident's substitute decision-maker, if any, and any person either of them may direct, setting out a detailed explanation of the supporting facts, as they relate both to the home and to the resident's condition and requirements for care, that justify the licensee's decision to discharge the resident. O. Reg. 79/10, s. 148 (2).

Findings/Faits saillants :



1. The licensee has failed to ensure that before discharging a resident under subsection 145 (1) that alternatives to discharge have been considered and, where appropriate, tried;
- (b) in collaboration with the appropriate placement coordinator and other health service organizations, make alternative arrangements for the accommodation, care and secure environment required by the resident;
- (c) ensure the resident and the resident's substitute decision-maker, if any, and any person either of them may direct is kept informed and given an opportunity to participate in the discharge planning and that his or her wishes are taken into consideration; and
- (d) provide a written notice to the resident, the resident's substitute decision-maker, if any, and any person either of them may direct, setting out a detailed explanation of the supporting facts, as they relate both to the home and to the resident's condition and requirements for care, that justify the licensee's decision to discharge the resident.

Related to Log #030273-18

A complaint related to the discharge of a resident was submitted to the Director. Review of the complaint information and telephone interview with the complainant indicated the Central East Health Integration Network (CELHIN) had concerns related to the discharge of resident #001 from the home, after the resident had been transferred to the hospital for further assessment due to the resident's responsive behaviours towards other residents and staff.

A telephone interview with the Director of Care, indicated, prior to the discharge of resident #001, there had been no written notice or previous discussion with the resident, the resident's Substitute Decision Maker and the appropriate Placement Coordinator related to assistance with the consideration of alternatives to discharge or alternate accommodation.

The licensee failed to ensure that alternatives to discharge had been considered and, where appropriate, tried in collaboration with the appropriate Placement Coordinator to make alternative arrangements for the accommodation, care and secure environment required by resident #001 and to provide a written notice to the resident, the resident's Substitute Decision Maker prior to the discharge. Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that alternatives to discharge have been considered and, where appropriate, tried; (b) in collaboration with the appropriate Placement Coordinator and other health service organizations, make alternative arrangements for the accommodation, care and secure environment required by the resident; (c) ensure the resident and the resident's substitute decision-maker, if any, and any person either of them may direct is kept informed and given an opportunity to participate in the discharge planning and that his or her wishes are taken into consideration; and (d) provide a written notice to the resident, the resident's substitute decision-maker, if any, and any person either of them may direct, setting out a detailed explanation of the supporting facts, as they relate both to the home and to the resident's condition and requirements for care, that justify the licensee's decision to discharge the resident, to be implemented voluntarily.
