The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): February 8, 9, 10, 11, 12, 16, and 17, 2016.

Log # 004693-16 related to a complaint regarding infection control and reporting of an outbreak.

During the course of the inspection, the inspector(s) spoke with Residents, Residents' family members, Personal Support Workers(PSW), Registered Practical Nurses (RPN), Registered Nurses(RN), the RAI Coordinator, Dietary aides, the Resident and Family Council Presidents, the Director of Care and the Administrator.

During the course of the inspection, the inspector conducted a tour of the home, observed one dining room during lunch, observed resident to resident interactions and care areas, observed medication administration and practices, reviewed resident health care records, observed and reviewed infection control practices, reviewed resident and family council minutes, the home's staffing schedules for the nursing department and the licensee's applicable policies.
