WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care
Specifically failed to comply with the following subsections:

s. 6. (5) The licensee shall ensure that the resident, the resident's substitute decision-maker, if any, and any other persons designated by the resident or substitute decision-maker are given an opportunity to participate fully in the development and implementation of the resident's plan of care. 2007, c. 8, s. 6 (5).

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
(a) a goal in the plan is met;
(b) the resident's care needs change or care set out in the plan is no longer necessary; or
(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The following findings are in relation to log # 0-001742-11:

A resident had a weight loss of greater than 7.5% and no referral and or assessment had been completed by the Registered Dietitian.

The plan of care had not been reviewed and revised in relation to nutrition and hydration needs.

2. The following findings are in relation to log # 001742-11.

A Power of Attorney for Personal Care provided a written request and permission to restrain a resident. A review of the physician orders as well as progress notes did not indicate that the resident had received new orders and that a restrain had been put in place. Staff of the home failed to implement the plan of care.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all resident plans of care are reviewed and revised as residents needs change, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

Specifically failed to comply with the following subsections:

s. 30. (2) The licensee shall ensure that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions are documented. O. Reg. 79/10, s. 30 (2).

Findings/Faits saillants :

1. The following findings are in relation to log # 0-001742-11:

A 72 hour food intake study was initiated for a resident. A review of the documentation indicated that only two meals had been recorded and no snacks were documented.

No documented assessments were completed for a resident for greater than 48 hours following a change in the residents health condition.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that assessments, interventions and resident responses to interventions are documented, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 32. Every licensee of a long-term care home shall ensure that each resident of the home receives individualized personal care, including hygiene care and grooming, on a daily basis. O. Reg. 79/10, s. 32.

Findings/Faits saillants :

1. The following findings are in relation to log # 0-000758-11

It was observed that two residents had not been shaven. A review of the plan of care and nursing progress notes did not indicate that they were resistive to care.
