The Eby dining room was taken out of commission for a two day period in June 2011 for minor renovations. The flooring material was replaced and the walls repainted. The residents were required to have their meals in an adjoining space until the renovations were completed. The home did not inform the Director.

Additional Required Action:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O.2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with respect to ensuring that alterations, additions or renovations to the home not commence without first receiving the approval of the Director.
