# INSPECTION SUMMARY

## **INSPECTION RESULTS**

#### WRITTEN NOTIFICATION: CMOH AND MOH

## NC #001 Written Notification pursuant to FLTCA, 2021, s. 154(1)1

Non-compliance with: O. Reg. 246/22 s. 272.



The licensee has failed to ensure that Directive #3 was followed in the home.

## **Rationale and Summary**

Directive #3 required Long-Term Care Homes (LTCH) to ensure that all individuals, including staff and visitors, are actively screened for symptoms and exposure history for COVID-19 before they are allowed to enter the home. LTCHs must follow the Ministry of Health's COVID-19 Screening Tool for LTCHs, effective March 18, 2022.

However, the following observations conducted by the home's surveillance screeners showed that multiple staff and visitors were not actively screened upon entry to the home:

- During a specific time period on May 10, 2022, ten out of ten individuals were not actively screened upon entry to the LTCH.
- During a specific time period on May 12, 2022, three out of three individuals were not active screened upon entry to the LTCH.

The surveillance screeners acknowledged that they did not ask staff and visitors the full COVID-19 screening questionnaire and said that it was because they were familiar with the individuals who visited the home regularly. One of the screeners said they did not feel it was necessary to ask individuals if they previously tested positive for COVID-19 because they were going to complete a rapid antigen test anyway. Another screener also shared that they allowed entry to family and visitors who experienced symptoms compatible with COVID-19 (i.e., runny nose or headache). The surveillance screeners said they entered positive responses for the omitted screening questions on behalf of the individuals being screened.

There was moderate risk for disease transmission when the home's designated surveillance screeners did not actively screen multiple staff and visitors upon entering the home.
