The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): June 8, 9, 10, 11, 14, 15, 2021.

The following intake was completed during this Critical Incident (CI) System inspection:

- Log #008252-21, CI #2743-000011-21, regarding an alleged resident to resident sexual abuse

During the course of the inspection, the inspector(s) spoke with the Administrator, Registered Nurses (RN), Personal Support Workers (PSW), Behaviour Support Ontario (BSO) Personal Support Worker, and residents.

Also during the course of the inspection, observations were completed of resident home areas and resident rooms, of the interactions between residents, and of the provision of care and services to residents. A record review was also completed of Critical Incident System reporting, resident healthcare records including plans of care, progress notes and behaviour monitoring.
