WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44. Authorization for admission to a home Specifically failed to comply with the following:

- s. 44. (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,
- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).
- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,
- (a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).
- (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).
- (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).
- (d) contact information for the Director. 2007, c. 8, s. 44. (9).

### Findings/Faits saillants:

1. Under the LTCHA, 2007, s. 44(7) The appropriate placement coordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43(6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless, (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval.

Related to log #019055-19:

A complaint from the Central East Local Health Integration Network was received by the Director on an identified date indicating an applicant had been refused admission to Chartwell Wynfield LTCH.

A review of the applicant's refusal letter for admission from the licensee indicated the applicant was refused admission because the home did not have the resources the applicant needed. Specifically, the licensee's staff lacked the nursing expertise to meet the applicant's care requirements and the licensee could not provide the care that the applicant needed and could effectively manage.

The explanation provided by the licensee to support that the staff of the LTCH lacked the nursing expertise related to specified responsive behaviours and diagnosis. Based on that information, the licensee indicated that the communal living environment of the home, would trigger the applicant to have responsive behaviours. The refusal letter was signed by the Director of Care (DOC) of the Long-Term Care Home.

In a telephone interview with Inspector #571 on an identified date, the DOC of the LTCH indicated that the home lacked the nursing expertise to provide care for the applicant because the staff would be unable to manage the applicant's specified responsive behaviours. The DOC further explained that the staff lacked the nursing expertise to manage a specified diagnosis because the licensee has Registered Practical Nurses working on the units.

In the same interview, Inspector #571 inquired about resources available to the licensee to assist with managing the applicant's responsive behaviours and specified diagnosis. The DOC indicated that they have the following resources: two Registered Nurses working in the home 24 hours per day; access to Nurse Practitioners and Physicians; a behaviour support Ontario (BSO) team comprised of one RPN and two Personal Support Workers (PSW) whose only duties are related to management of responsive behaviours; access to supports that can provide education to staff; and the Assistant Director of Care whose role includes staff education. In addition, the DOC is familiar with the High Intensity Needs fund for funding for one to one staffing for residents with specified care needs.

The documented evidence provided by the licensee did not support how staff of the home lack the nursing expertise necessary to meet the applicant's care requirements. [s.

2. The licensee has failed to ensure that when withholding approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval; and contact information for the Director. 2007, c. 8, s. 44 (9).

Related to log #019055-19:

A complaint from the Central East Local Health Integration Network was received by the Director on an identified date indicating an applicant had been refused admission to Chartwell Wynfield LTCH.

A review of the applicant's refusal letter for admission from the licensee indicated the applicant was refused admission because the home did not have the resources the applicant needed. Specifically, the licensee's staff lacked the nursing expertise to meet the applicant's care requirements and the licensee could not provide the care the applicant needed as the care needs would be more than the licensee could effectively manage.

The explanation provided by the licensee was that the applicant had a specified diagnosis and specified responsive behaviours. Based on that information, the licensee indicated that the communal living environment of the home, would trigger the applicant to have responsive behaviours. The refusal letter was signed by the Director of Care (DOC) of the Long-Term Care Home.

The letter did not provide for an explanation of how the supporting facts justify the decision to withhold approval for admission. [s. 44. (9) (c)]
