Two intakes related to alleged incidents of staff to resident and resident to resident abuse.

One intake related to a complaint regarding the provision of the resident's plan of care, pain management and resident abuse and/or neglect.

During the course of the inspection, the inspector(s) spoke with the Administrator, VP of Corporate Operations, Corporate Director of Clinical Services, Interim Director of Care, Associate Directors of Care, Environmental Manager, Physiotherapist, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSWs), front secretary, health screeners, Housekeepers and residents.

The inspector(s) reviewed clinical health records of identified residents, internal policies related to Falls Prevention, Prevention of Abuse and Neglect and Responsive Behaviours. The Inspector(s) also observed staff to resident and resident to resident care and interactions.
