WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect

Specifically failed to comply with the following subsections:

## s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

## Findings/Faits saillants :

During personal care a resident became verbally and physically aggressive (striking out) towards the staff and threatening to kick them. A Personal Care Worker (PSW) was observed by another PSW, physically abusing the resident and causing the resident to experience pain. The incident was reported and the resident was assessed as having no physical injuries. The PSW who abused the resident was immediately suspended. Administrative staff completed an internal abuse investigation and determined that the resident had been physically abused. The Port Hope Police Department were notified and Witness Statements provided to them. The employee received termination notice on or about August 9, 2011.
