The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): November 30, December 1, 2, 3, 2015.

Critical incident number M615-000006-15, log number 030753-15, related to an injury resulting in a significant change and a transfer to hospital, was also inspected concurrently within the Resident Quality Inspection.

During the course of the inspection, the inspector(s) spoke with the Manager, the Resident Assessment Instrument (RAI) Coordinator, the Assistant Food Services Manager, the Secretary, one Recreation Staff, four Registered Nurses (RN), one Registered Practical Nurse (RPN), seven Personal Support Workers (PSW), three Family Members, and 34 Residents.

During the course of the inspection, the inspector(s) toured the home, observed meal service, medication passes, medication storage areas and care provided to Residents, reviewed health records and plans of care for Residents, reviewed policies and procedures of the home, and observed general maintenance, cleaning and condition of the home.
