Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

During the course of the inspection, the inspector(s) spoke with administrator and director of care regarding the home's safety and security program which was found to be in non-compliance on November 24 & 25, 2011. An Order (#001) was issued for non-compliance with O. Reg. 79/10, s. 5 related to the home's processes with respect to ensuring that the home's doors are adequately secured against resident egress.(2011-072120-0043/H-002335-11). During this inspection, compliance with s. 5 was verified and the Order cleared.

During the course of the inspection, the inspector(s) randomly tested stairwell doors, reviewed the fire safety policies and procedures, fire drill logs, minutes of meetings related to fire drills, memos, staff education needs evaluations and fire safety education materials.(H-000681-12)
