WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 26. Plan of care Specifically failed to comply with the following:

s. 26. (3) A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident: 19. Safety risks. O. Reg. 79/10, s. 26 (3).

Findings/Faits saillants:

- 1. The licensee did not ensure that the plan of care was based on, at a minimum, interdisciplinary assessment with respect to the resident's safety risks.
- a) Resident #001 was admitted to the home in 2011. According to the admission record, the resident was known to have specific responsive behaviours, which posed a serious safety risk. The clinical record identified at least five occasions in 2011, where the resident exhibited this behaviour. On an identified date in 2011, staff intervened during an episode of responsive behaviour before the resident sustained any injuries. The DOC confirmed there was no assessment completed or strategies developed to manage the safety risk until after the resident had exhibited multiple episodes.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the plans of care are based on, at a minimum, interdisciplinary assessment with respect to the resident's safety risks, to be implemented voluntarily.
