The purpose of this inspection was to conduct a Complaint inspection.

Please note: Two areas of non-compliance were found related to the Licensee's failure to report incidents related to medication incidents and adverse drug reactions and administration of drugs. These areas of non-compliance [O.Reg.79/10, 131. (2) and s 135 (1) were issued in Inspection #2013_188168_0015 conducted on March 19, 20, 21, 22, 25, 26, 27, 28 and April 2, 3, and 5, 2013, and are contained in the Report of that inspection.

During the course of the inspection, the inspector(s) spoke with The Director of Care, Charge Nurse, Registered Staff, personal support workers, residents and families.

During the course of the inspection, the inspector(s) interviewed staff, residents and families, reviewed relevant policies, procedures, protocols and clinical records related to H-0002015-12/H-000178-13.
