The licensee has failed to ensure that when withholding approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval; and contact information for the Director. 2007, c. 8, s. 44 (9).

This inspection was initiated related to a complaint received by the Ministry of Health and Long Term Care, complaint #011032-18 related to applicant #001. The complaint pertains to withholding approval for admission to St Joseph's at Fleming.

An application for admission was made to the LTCH. The licensee provided a letter of refusal for admission to applicant #001's Substitute Decision Maker on a specified date. The explanation for the refusal provided in the letter indicated that the LTCH would be unable to manage applicant #001's level of care related to several specified responsive behaviours that the applicant displayed.

During an interview with the Manager of Strategy and Special Projects, they confirmed the reasons the application for admission was denied.

The letter does not provide for a detailed explanation of the supporting facts, as they related both to the home and to the applicant's condition and requirements for care, an explanation of how the supporting facts justify the decision to withhold approval or the contact information for the Director.
