1. The licensee has failed to ensure that when withholding approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out, the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval. 2007, c. 8, s. 44 (9).

A complaint was submitted to the Director by the Central East Local Health Integration Network (LHIN). The complaint pertained to withholding approval for admission to St. Joseph's at Fleming for resident #001.

A review of the bed refusal letter addressed to resident #001 indicated that the home was unable to accept the admission as the home lacked the physical facilities necessary to meet the applicant's care requirements.

In an interview with the CEO, they acknowledged that the letter did not include sufficient supporting details as required, for withholding an approval for admission.

The licensee failed to ensure that the refusal letter for re-admission, provided a detailed explanation of the supporting facts, as they related both to the home and to the applicant's condition and requirements for care, and an explanation of how the supporting facts justify the decision to withhold approval.
