**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): October 28, 2015**

An inspection (Resident Quality Inspection #2015-337581-0011) was previously conducted in June 2015 and two Orders were issued on July 23, 2015, Order #001 related to bed safety and Order #002 related to the prevention of abuse and neglect. For this follow-up inspection, both Orders were verified to have been met and closed.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care and Associate Director of Care regarding bed safety and their prevention of abuse/neglect program in the home. The inspector reviewed the home's bed safety program, response plan for Order #002, personal support worker roles and responsibilities when arriving to work or during shift changes, care plans and assessments for 2 identified residents and confirmed that the home's program (training, reporting, policies and procedures) regarding neglect/abuse complied with requirements in the Long Term Care Homes legislation.
