The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 7, 8, 2019

This inspection was conducted in relation to the availability of medical, infection control and continence supplies.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, registered staff, personal support workers and a maintenance person.

During the course of the inspection, the inspector toured three home areas, tub and shower rooms, storage rooms, medication supply rooms, random resident rooms, reviewed the quantity of medical supplies, resident continence supplies, falls prevention devices (bed and chair alarms), gloves, gowns and specimen containers. The licensee's continence care and bowel management program (procedures, staff training and resident assessments) were also reviewed.

During the course of this inspection, Non-Compliances were not issued.
