Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 11 and 12, 2020, as an on-site inspection and June 17 and 18, 2020, as an off-site inspection.

The following Critical Incident (CI) intakes were completed within this inspection:

Log #021839-19/CI #2938-000029-19 related to allegations of resident abuse; and Log #024461-19/CI #2938-000034-19 related to allegations of resident abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Assistant Director of Care (ADOC), a Registered Practical Nurse (RPN), two Personal Support Workers (PSWs) and residents.

The Inspector also observed residents and the care provided to them, reviewed clinical records and the plans of care for the identified residents and reviewed the home's documentation related to the incidents.
