The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Assistant Director of Care (ADOC), the Manager of Resident Quality Care, the Food Services Manager, a Registered Nurse (RN), a Registered Practical Nurse (RPN), two Personal Support Workers (PSWs) and residents.

The Inspector also observed staff interactions with residents, the care being provided to residents and falls prevention and medication management practices in the home; and reviewed clinical records and plans of care for the identified residents and the home's documentation related to the incidents.
