Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 11, 12, 13 and 14, 2020.

The following Critical Incident (CI) System intakes were completed within this inspection:

Log #000564-20/CI #2939-000002-20 related to allegations of resident abuse and neglect.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), an Assistant Director of Care (ADOC), a Corporate Consultant, a Social Worker, a Scheduling Clerk, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), residents and visitors.

The Inspectors also observed residents and the care provided to them, reviewed clinical records and plans of care for the identified resident and reviewed the home's investigation notes and documentation related to the incident.

This inspection was conducted concurrently with Complaint Inspection #2020_788721_0005.

Inspector Christy Legouffe #730 was also present during this inspection.
