The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): November 26, 2013

During the course of the inspection, the inspector(s) spoke with a Director of Care, an Environmental Services Manager, a Food Services Manager, an external Electrical Service Company Supervisor, a Maintenance Worker, two residents, two resident family members, a Registered Practical Nurse and three Personal Support Workers.

During the course of the inspection, the inspector(s) reviewed the Critical Incident, the compliance history of the home, the maintenance logs, an external maintenance log, staff scheduling, logs relating to increased monitoring of residents, observed for general resident safety and tested call bells on all units.
