Non-compliance with requirements under the Long-Term Care the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

s. 6. (8) The licensee shall ensure that the staff and others who provide direct care to a resident are kept aware of the contents of the resident's plan of care and have convenient and immediate access to it. 2007, c. 8, s, 6

Findings/Faits saillants:

1. The licensee failed to ensure that staff and others who provide care to resident #1 were kept aware of the contents of the plan of care and have convenient and immediate access to it.

A review of health records identified that the plan of care for an identified resident was revised on a specified date in 2012. The plan of care stated that the resident was routinely refusing dinner and the family would like resident to be offered sandwich made with assorted minced filling (no crust)for dinner daily. However, the dietary staff who provided direct care interviewed were not aware of resident's food preferences requested by the family. The content of the plan of care regarding resident's dietary requirements were not communicated to staff. Resident's individual nutritional approach and needs were not transcribed to the dietary kardex(diet list) for staff reference, until August 3,2012. The food service supervisor confirmed that the dietary staff was not aware of the content of the plan of care related to resident's family request for minced meat sandwich to be offered to resident at dinner daily.
