- (a) **the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).**
- (b) **the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).**
- (c) **circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).**

1. The licensee failed to approve an applicant's admission to the home based on assessments and information under subsection 43 (6) unless: a) the home lacked the physical facilities necessary to meet the applicant's care requirements or; b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements.

As a result of a complaint inspection related to refusal to admit applicant #007, the Long-Term Care Homes (LTCH) Inspector reviewed a copy of the home's refusal to admit letter, with no date, that was addressed to the Central West Community Care Access Centre (CCAC). The applicant and the Director were not included in the mailings.

The letter stated the care requirements of the applicant were outside the resources and scope of practice to accommodate this applicant at the home. It did not include a detailed explanation of the supporting facts as they related to the home and the applicant's condition and requirements for care.

Registered Practical Nurse (RPN) #103 told the LTCH Inspector the home employs a full-time Behavioural Supports Ontario (BSO) nurse, a full-time Nurse Practitioner (NP) and regularly utilizes the homes Ontario Telemedicine Network (OTN) for appointments and therapy sessions with a psychiatrist.

The Administrator was knowledgeable about the use of high intensity needs (HIN) funding available if required. They stated they were not aware the applicant and the Director were to receive a copy of the letter and that contact information for the Director was to be included in the letter of refusal to admit an applicant.

The licensee failed to approve the applicant's admission to the home when the home had the resources and scope of practice to meet the applicant's care requirements. [s. 44. (7) (b)]
