The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 16 - 20, 2019.

The following Critical Incidents were inspected during this inspection:

One Critical Incident report that was submitted to the Director regarding a fall resulting in an injury and transfer to the hospital;

One Critical Incident report that was submitted to the Director regarding an injury of unknown cause and transfer to the hospital.

A concurrent Complaint Inspection #2019_509613_0025, was also conducted during this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Assistant Administrator, Director of Resident Care (DRC), Assistant Director of Resident Care (ADRC), Physiotherapist, Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and residents.

The Inspector also conducted daily tours of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions, reviewed health care records, and policies, procedures and programs.
