Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the Items listed in the definition of requirement under this Act! in subsection 2(1) of the LTCHA.)

The following constitutes Written notification of non-compliance under paragraph 1 of section 152 of the LTCHA:

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 129. Safe storage of drugs Specifically failed to comply with the following subsections:

- s. 129. (1) Every licensee of a long-term care home shall ensure that,
- (a) drugs are stored in an area or a medication cart,
- (i) that is used exclusively for drugs and drug-related supplies,
- (ii) that is secure and locked,
- (iii) that protects the drugs from heat, light, humidity or other environmental conditions in order to maintain efficacy, and
- (iv) that complies with manufacturer's instructions for the storage of the drugs; and
- (b) controlled substances are stored in a separate, double-locked stationary cupboard in the locked area or stored in a separate locked area within the locked medication cart. O. Reg. 79/10, s. 129 (1).

### Findings/Faits sayants:

On July 13 and 14, 2011, money was observed stored in two identified residents' medication bins. Also a bottle of beer was observed in the medication fridge in the medication room. [129(1)(a)(i)]

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 136. Drug destruction and disposal Specifically failed to comply with the following subsections:

- s. 136. (2) The drug destruction and disposal policy must also provide for the following:
- 1. That drugs that are to be destroyed and disposed of shall be stored safely and securely within the home, separate from drugs that are available for administration to a resident, until the destruction and disposal occurs.
- 2. That any controlled substance that is to be destroyed and disposed of shall be stored in a double-locked storage area within the home, separate from any controlled substance that is available for administration to a resident, until the destruction and disposal occurs.
- 3. That drugs are destroyed and disposed of in a safe and environmentally appropriate manner in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices.
- 4. That drugs that are to be destroyed are destroyed in accordance with subsection (3). O. Reg. 79/10, s. 136 (2).

#### Findings/Faits sayants:

The home does not have a double locked storage area for controlled substances to be stored until they are destroyed and disposed on evenings, nights and weekends, separate from any controlled substances available for administration. Controlled substances are being kept in the same double locked narcotic bin in the medication cart with the controlled substances available for administration until the Assistant of the Director of Care picks them up.

### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring that any controlled substance that is to be destroyed and disposed is stored in a double locked storage area within the home, separate from any controlled substance that is available for administration to a resident, until the destruction and disposal occurs, to be implemented voluntarily.
