Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 28 and 29, 2019, September 3 - 6, 9 and 10, 2019

The Critical Incident System (CIS) Log(s) #009135-19 and #012266-19 related to Falls prevention and management. Log #017251-19, related to prevention of resident Abuse and Neglect was inspected during this inspection.

Follow up Log #009661-19 - CO #002 from Inspection #2019_785732_0006 related to Duty to protect s. 19. (1) Compliance due date August 16, 2019 was conducted concurrently during this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Resident Care Coordinators (RCC), Registered Nurses (RN), Registered Practical Nurses (RPN), Recreation staff, Food Service Workers (FSW), Housekeeping Staff, Personal Support Workers (PSW), Behavioural Supports Ontario personal staff (BSO) and staffing clerk.

During the course of the inspection, Inspector reviewed critical incident reports, licensee's internal investigation documentation, as applicable, licensee's policies related to the prevention of Abuse and Neglect, Whistle blower Protection, residents' health care record, staff training materials and attendance records. In addition, the inspector observed the provision of care and services to residents, observed staff to resident interactions and observed resident to resident interactions.
