## Findings/Faits saillants:

1. Concerns identified related to staff participation in the implementation of the infection prevention and control program include:

During a tour of the home items were found to be stored inappropriately.

Staff confirmed that the items were stored inappropriately and provided information on proper storage and infection control practices.

During the meal service, a staff member was observed utilizing the soiled linen/laundry cart, to transport and document the resident's intake in the food and fluid binder.
