Specifically failed to comply with the following:

(a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).

(b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9). (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).

(d) contact information for the Director. 2007, c. 8, s. 44. (9).

Findings/Faits saillants:

1. The Licensee has failed to ensure that written notice, including a detailed explanation of the supporting facts as they related both to the home and to the applicant's condition and requirements for care and an explanation of how the supporting facts justified the decision to withhold approval, was provided when they withheld approval for admission to residents/applicants #001, #002 and #003.

Review of placement documents identified that the written reason for withholding approval of admission for residents/applicants #001, #002 and #003 was, "resources we have and the need of the other residents in our facility". No explanation of the supporting facts or how the facts justified the decision to withhold approval for admission were provided.

Interview with the DOC confirmed the reason for denial to be accurate and confirmed that it did not meet the detail as required by the Legislation when withholding admission.
