Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): June 7-11, 2021.

The following intake(s) were inspected upon during this Follow Up inspection:

-One log, which was related to compliance order #001 from inspection report #2021_824736_0006, where the home was ordered to comply with section 229 subsection 4 of the Ontario Regulations (O. Reg.) 79/10, related to the licensee ensuring that all staff participate in the implementation of the Infection Prevention and Control (IPAC) program, specifically, the appropriate usage of Personal Protective Equipment (PPE) and Hand Hygiene, as well as ensuring the appropriate signage was posted in the home, with a compliance due date of April 30, 2021; and,

-One log, which was related to compliance order #001 from inspection report #2021_824736_0005, where the home was ordered to comply with section 36 of the O. Reg. 79/10, related to the licensee preparing and implementing a plan ensuring that staff use safe transferring and positioning devices when assisting residents, with a compliance due date of May 14, 2021.

A Critical Incident System (CIS) inspection #2021_853692_0012 and a CIS Eldcap inspection #2021_853693_0013 were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Nursing (DON), Associate Director of Nursing (ADON), Infection Prevention and Control (IPAC) Lead, Nurse Managers (NMs), Housekeepers, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Nursing Support Aides (NSAs), and residents.

The Inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident and resident to resident interactions, observed infection control practices, reviewed relevant health care records, internal investigation notes, as well as licensee policies, procedures and programs.
