1. The licensee of the long term care home did not ensure that the following rights of residents are fully respected and promoted: Every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential and to be given reasonable assistance by the licensee to pursue these interests and to develop his or her potential. Transportation was booked for resident #1 for a family event in 2012 however, the home confirmed that the resident was not ready when the transportation arrived and the resident missed the event. The home's process for residents requiring transportation was to have residents ready 15 minutes prior to the scheduled pick up time. [s. 3. (1) 23.]
