Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (Une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.
Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD:

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 53. Responsive behaviours Specifically failed to comply with the following subsections:

- s. 53. (1) Every licensee of a long-term care home shall ensure that the following are developed to meet the needs of residents with responsive behaviours:
- 1. Written approaches to care, including screening protocols, assessment, reassessment and identification of behavioural triggers that may result in responsive behaviours, whether cognitive, physical, emotional, social, environmental or other.
- 2. Written strategies, including techniques and interventions, to prevent, minimize or respond to the responsive behaviours.
- 3. Resident monitoring and internal reporting protocols.
- 4. Protocols for the referral of residents to specialized resources where required. O. Reg. 79/10, s. 53 (1).

Findings/Faits saillants:

- 1. There are frequent changes to approaches and interventions required for several residents exhibiting behavioural symptoms on the unit.
- 2. The most current approaches and/or changes to interventions for residents are not always communicated in a consistent place or method.
- 3. Staff are unclear about the most current approach for specific residents. [O.Reg. 79/10 s.53(1)3]
