WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 231. Resident records Every licensee of a long-term care home shall ensure that,

- (a) a written record is created and maintained for each resident of the home; and
- (b) the resident's written record is kept up to date at all times. O. Reg. 79/10, s. 231.

Findings/Faits saillants:

- 1. The clinical record for one resident is not kept up to date. The resident health record does not include documentation to confirm:
- A) two treatments were completed as directed in the written plan of care
- B) one weekly skin assessment of the resident's wound was completed as directed in the written plan of care. [{O.Reg.70/10,s.231(b)}

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 122. Purchasing and handling of drugs Specifically failed to comply with the following subsections:

- s. 122. (1) Every licensee of a long-term care home shall ensure that no drug is acquired, received or stored by or in the home or kept by a resident under subsection 131 (7) unless the drug,
- (a) has been prescribed for a resident or obtained for the purposes of the emergency drug supply referred to in section 123; and
- (b) has been provided by, or through an arrangement made by, the pharmacy service provider or the Government of Ontario. O. Reg. 79/10, s. 122 (1).

Findings/Faits saillants :

- 1. A) Review of the health record for one resident confirmed the treatment initiated by registered personnel has not been prescribed by a physician.
- B) Review of the home's Medical Directives protocol for physician's does not include a directive for registered personnel to implement the home's wound management program.[O.Reg.79/10,s.122(1)(a)]
