Findings/Faits saillants:

1. The licensee of the home did not ensure there is a written plan of care for each resident that sets out the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident. One resident participates in a program developed to address her needs. Review of the resident health record and interview with three staff confirmed there is not a written care plan for the program that sets out the goals the program is intended to achieve and clear directions to staff or others who provide direct care to the resident. [s.6(1)(b)(c)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to ensuring the written plan of care for each resident sets out the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident, to be implemented voluntarily.
