Inspection Summary/Résumé de l'inspection

Inspection Report under the Long-Term Care Homes Act, 2007**Rapport d'inspection en vertu de la Loi de 2007 sur les foyers de soins de longue durée**

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 10-14, August 17, off site August 18-20, September 15, 2020.

The following intakes were inspected:

**Log #006206-20 (CIS #M625-000010-20) and Log #011446-20 (CIS #M625-000013-20)-resident falls that resulted in injuries,
Log #012512-20 (CIS #M625-000014-20)-alleged incidents of staff to resident abuse,
and
Log #015446-20 (CIS #M625-000017-20)-resident elopement.**

Note: A Written Notification related to LTCHA, 2007, s. 20 (1) was identified in a concurrent inspection #2020_505103_0012 (Log #015422-20, CIS #M625-000016-20 and Log #015546-20) and issued in this report.

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), RAI coordinator, Assistant Manager of Nursing (AMON), Manager of Nursing (MON) and the Administrator.

During the course of the inspection, the inspector made resident observations, reviewed the critical incidents associated with each of the intakes, resident health care records, the licensee's abuse policy, "Abuse-Resident Rights and Safety", #01-20-10, revised January 2020, the home's investigation notes related to the alleged incidents of abuse, and applicable policies related to door security.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19.
Duty to protect**

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee failed to ensure residents were protected from abuse by a PSW.

Physical abuse is defined by O. Reg 79/10 as the use of physical force by anyone other than a resident that causes physical injury or pain.

Two residents reported to staff they had received injuries as a result of care provided by a PSW. The home failed to protect these residents by not immediately investigating these allegations. The PSW continued to work and care for the two residents on a subsequent shift following the allegations which put those and other residents at risk for potential physical abuse.

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 20.
Policy to promote zero tolerance**

s. 20. (1) Without in any way restricting the generality of the duty provided for in section 19, every licensee shall ensure that there is in place a written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with. 2007, c. 8, s. 20 (1).

Findings/Faits saillants :

1. The licensee failed to ensure their written policy to promote zero tolerance of resident abuse was complied with.

Alleged incidents of staff to resident abuse occurred as outlined in Written Notification (WN) #1. The allegations of physical abuse were not immediately investigated and a medical assessment of the injuries sustained by the residents was not completed in accordance with the abuse policy. Additionally, the alleged incidents of physical abuse were not immediately reported to the Ministry of Long-Term Care (MLTC), the police, the substitute decision-makers (SDM) and the physician as required by the abuse policy. [s. 20. (1)]

2. Staff discovered a co-resident in another resident's room. One resident was visibly upset and complaining of pain and alleged the other resident had acted inappropriately towards them. A medical assessment of the resident complaining of pain was not immediately completed as required by the abuse policy. [s. 20. (1)]

WN #3: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 23. Licensee must investigate, respond and act

1. The licensee failed to ensure alleged incidents of staff to resident abuse were immediately investigated.

Alleged incidents of staff to resident abuse occurred as outlined in WN #1 and were not immediately investigated.

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. An RN failed to immediately report to the Director (MLTC) alleged incidents of staff to resident physical abuse.

As outlined in WN #1, alleged incidents of staff to resident abuse occurred and were not immediately reported to the Director.

WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 97. Notification re incidents

Specifically failed to comply with the following:

s. 97. (1) Every licensee of a long-term care home shall ensure that the resident's substitute decision-maker, if any, and any other person specified by the resident,
(a) are notified immediately upon the licensee becoming aware of an alleged, suspected or witnessed incident of abuse or neglect of the resident that has resulted in a physical injury or pain to the resident or that causes distress to the resident that could potentially be detrimental to the resident's health or well-being; and
(b) are notified within 12 hours upon the licensee becoming aware of any other alleged, suspected or witnessed incident of abuse or neglect of the resident. O. Reg. 79/10, s. 97 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure SDM's were immediately notified of alleged incidents of staff to resident physical abuse that resulted in physical injuries.

As outlined in WN #1, alleged incidents of staff to resident abuse occurred and were not immediately reported to the SDM's.

WN #6: The Licensee has failed to comply with O.Reg 79/10, s. 98. Every licensee of a long-term care home shall ensure that the appropriate police force is immediately notified of any alleged, suspected or witnessed incident of abuse or neglect of a resident that the licensee suspects may constitute a criminal offence. O. Reg. 79/10, s. 98.

-Upon the completion of the refresher training, the PSW shall be scheduled observation/buddy shifts whereby resident care provided by the PSW can be observed and assessed as safe. Observation shifts may be discontinued when management has assessed resident care as being provided in a safe manner.

-Provide the RN with refresher training on resident abuse and the licensee's abuse policy. The Manager of Nursing (MON) shall meet with the RN to review their obligations as a charge person related to the reporting and investigation of all alleged, suspected and witnessed incidents of resident abuse and to outline actions that will be taken for future non-compliance with these obligations.

-Keep a record of all meetings, training provided, observations shifts including the dates and the persons who attended.

Compliance History: The licensee was previously found to be in non-compliance with different sections of the legislation in the past 36 months.
