The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted in reference to intake logs #007414-21; CIS #M625-000019-21, #025205-20, CIS #M625-000033-20; #000950-21, CIS #M625-000001-21; #000957-21, CIS #M625-000002-21; and #006471-21, CIS #M625-000016-21, related to residents having fallen resulting in an injury; intake log #006761-21, CIS #M625-000018-21 related to resident to resident responsive behaviours; and intake logs #004713-21, CIS #M625-000007-21 and #025966-20, CIS #M625-000036-20 related to alleged staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Assistant Manager of Nursing / Infection Prevention and Control Lead, Registered Nurses, Registered Practical Nurses, Personal Support Workers and residents.
