The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

**WN #1: The Licensee has failed to comply with O. Reg 79/10, s. 110(2)(6)**

Every licensee shall ensure that the following requirements are met where a resident is being restrained by a physical device under section 31 of the Act:

6) That the resident's condition is reassessed and the effectiveness of the restraining evaluated only by a physician, a registered nurse in the extended class attending the resident or a member of the registered nursing staff, at least every eight hours, and at any other time when necessary based on the resident's condition or circumstances.

**Findings:**

The registered staff do not reassess the need for a seatbelt except on the quarterly medication review and during the quarterly RAI assessment.

**Additional Required Actions:**

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with the registered staff reassessing the need for restraint at least every 8 hours, to be implemented voluntarily.
