WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants:

1. The licensee has failed to ensure that the care set out in the plan of care was provided to resident #001 as specified in their plan.

Resident #001's plan of care directed staff to place both bed rails in the upright position when the resident was in bed. On an identified date in February,2015, resident #001 sustained a fall with injury, and it was confirmed that the side rail on the left side of the bed was lowered upon investigation of the incident. A review of the home's investigation notes confirmed that the resident did not release the side rail, and that the side rails were checked by the Maintenance Technician and were in good working order. The staff members that put the resident to bed prior to the incident could not confirm that the side rails latched prior to leaving the resident unattended and the resident falling. The home cannot confirm that the resident's plan of care was followed as specified in the resident's plan of care. [s. 6. (7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan is provided to residents as specified in their plans of care, to be implemented voluntarily.
