Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.) WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

The licensee of the home did not protect a resident from abuse by a worker. A personal support worker was witnessed by another person to have verbally and physically abused two residents, on two separate dates in 2011. An identified resident was verbally insulted regarding their personal hygiene when they refused to take a bath. The worker did not respect the resident's choice, was rough while undressing the resident and disrespectful with personal articles.

Another identified resident who was also being cared for by the same worker was cared for roughly and when they did not co-operate, was yelled at by the worker. A condescending comment was also made about the resident. The incidents of abuse were reported to the management of the home 5 days later by the witness. The management of the home took immediate action to determine the facts in both matters and took follow-up action.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents are protected from abuse by anyone, to be implemented voluntarily.
