Every licensee of a long-term care home shall ensure that, no medical directive or order for the administration of a drug to a resident is used unless it is individualized to the resident's condition and needs.

**Findings:**

A resident received 2 medications which the physician stated should not have been prescribed together from January 25, 2011 to January 31, 2011.
