The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with O. Reg. 79/10, s. 71(1)(b) Every licensee of a long-term care home shall ensure that the home's menu cycle, includes menus for regular, therapeutic and texture modified diets for both meals and snacks.

Findings:

Menus for residents with diet orders for Restricted Lactose diets are not available to guide staff for meals and snacks.

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that menus are available for all therapeutic diet orders, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O. Reg. 79/10, s. 71(1) (g) Every licensee of a long-term care home shall ensure that the home's menu cycle, is reviewed and updated at least annually.

Findings:

The last menu review completed was for the Spring and Summer menu in July 2009.

Additional Required Actions

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance, to ensure that the home's menu cycle is reviewed and updated at least annually, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O. Reg. 79/10, s. 71(2)(b) The licensee shall ensure that each menu, provides for a variety of foods, including fresh seasonal foods, each day from all food groups in keeping with Canada's Food Guide as it exists from time to time.

Findings:

The menu does not provide adequate servings of Breads and Cereals, in keeping with Canada's Food Guide, on a daily basis.
