The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): November 7, 8, 9 and 10, 2016.

The following inspections were completed within this Resident Quality Inspection:

During the course of the inspection, the inspector(s) spoke with the Administrator, three Resident Care Coordinators, the Registered Nurse/Resident Assessment Instrument Coordinator, Physician, Coroner, Nurse Practitioner, seven Registered Practical Nurses, nine Personal Support Workers, Housekeeper, Recreation Aide, Residents' Council Representative, residents and family members.

Inspectors also toured the resident home areas and common areas, observed resident care provision, resident/staff interactions, medication administration, medication storage areas, reviewed relevant residents' clinical records, posting of required information, relevant policies and procedures, as well as meeting minutes pertaining to the inspection, and observed infection prevention and control practices, general maintenance and cleanliness of the home.
