The inspector also observed interactions between staff and residents during the provision of care, dining, toured the home, reviewed clinical health records, maintenance service records, nursing practice meeting and PIECES committee meeting minutes, and the licensee's policies: Prevention, Reporting and Investigation of Abuse and Neglect, Responsive Behaviour Prevention and Management Program.
